## P-205 Rev A Additional Inspection Services Requirements

These requirements are *in addition to* all other requirements in purchase orders to machined part suppliers.

## **Documentation**

For each lot of inspected parts, the following documentation shall be emailed or, if posted, placed in one, 9" x 12" envelope:

• The completed CED Quality Assurance Record (QAR). If parts from more than one lot are used to satisfy an order, separate QAR's must be completed for each lot supplied.

Note: It is not necessary to pull separate samples from the whole lot for each AQL sample size. First, randomly select the maximum number of samples required by the Sample Size table below for the lot size, and then select the required samples for each check from that one group.

**Sample Sizes** 

Note: While not identical, sample sizes are guided by ANSI/ASQ Z1.4-2008, Table II-A – Single sampling plans for normal inspection (master table), with changes to some sample sizes and the following modifications:

- "Ac" and "Re" values are not used. In all cases, a single rejection shall result in 100% inspection of the lot for the rejected characteristic.
- In cases where the sample size of a less stringent AQL is the same or greater than the sample size of a more stringent AQL, the sample size of the less stringent AQL may be reduced to the next lower size.
- A legible copy of each required material certificate of conformance for each lot of parts
- A legible copy of each required processing certificate of conformance for each lot of parts

If the documentation is posted, the words "Inspection Documentation" shall be legibly written on the outside of the envelope and the envelope then placed in one of the part shipping containers.
